⁴ Class A and Class D services are exempt from the deductible. All other covered services are exempt from the deductible only when provided by a Delta Dental Federal Employees Dental Program network dentist. Per the missing tooth clause, services or treatment for the provision of an initial prosthodontic appliance (e.g., fixed bridge restoration, implants, removable partial or complete denture, etc.) when it replaces natural teeth extracted or missing, including congenital defects, prior to the effective date of coverage are not eligible for coverage.
